## New grocery store coming

Before the end of this year, a pair of Holton High School alumni are planning to open Cecil K's Hometown Market in the former Ron's IGA building.

"I think people in general are ready for a small store experience, and we're really excited to be filling that gap," said Carly Whorton, a 2006 HHS graduate who will own and operate the new market with cousin Chad Bontrager, a 2000 HHS graduate.

That "gap," Whorton said, is one that many people don't believe a big box store like Walmart can fill in the absence of smaller, more localized grocery stores like Ron's IGA, which closed at the end of March 2016, and Holton Country Mart, which closed earlier this year.

"It doesn't really feel like we're competing with Walmart so much as coexisting, because we'll be doing much different things," she said.

The store's namesake is Cecil Kern, great-grandfather to Whorton and Bontrager, who owned and operated a grocery store in Iola in the early 1930s. Kern would later move to Hoyt and work as a farmer-stockman south of Denison for most of his life until he died in 1998.

Whorton said she and Bontrager view the new grocery store as a "natural continuation of the family business that started almost 90 years ago."

The grocery store will also serve as a storefront with Heartland Meat Market, which currently operates an outlet store just off of Holton's Town Square. Whorton said Bontrager, as a partner in the Meriden-based meat business — which is owned by two other HHS alumni, David Tinney and Matt McCauley — suggested that Cecil K's serve as a storefront for their meat market.

"They were looking for a larger space to expand their Holton operations, and they had looked at a couple of spaces," Whorton said. "Chad said, wouldn't it be cool if there was a whole grocery store where Heartland Meat could just come in and operate the meat counter. So that's

## Bausch coming home as rodeo entertainer

This weekend's Jackson County Fair Rodeo will be a homecoming for featured entertainer Brian Bausch, a native of rural Mayetta, who now travels the world performing his cowboy show.

Bausch is the son of Richard and Helen Bausch, who operate a cow-calf operation in the southern part of the county.

"My dad had a ranch horse, and I grew up riding that and I would ride my brother's pony," Bausch said.

Bausch got his first horse when he was seven years old.

"I went and worked with Gordon Kern who helped me start that horse under saddle," he said.

Bausch said that even at a young age, he was experimenting with trick riding on a horse.

"My brother and I would throw sticks and sunflower stumps at each other trying to knock each other off our dad's single horse," he said. "We weren't very good at sharing so I started getting pretty good at hanging off the side of my horse, which, in the professional world, is called the Apache Hideaway. I also would stand up

in the saddle to avoid my brother jabbing me with a pitchfork."

Bausch took his first horse on long, hard rides and to calm him down before they arrived home, Bausch would stand up on him so he'd quit prancing and walk quietly.

"Soon I was standing on his back more than a mile away from the ranch," he said.

Bausch graduated from Royal Valley in 1992 and then from Kansas State University.

"Right after my last exam, I began working at a dude ranch in Michigan," he said. "I oversaw 100 head of horses, and it was a great learning experience for me."

The dude ranch hosted 400 guests a week, and Bausch said part of his job was instructing the guests how to ride horses safely and demonstrating different riding techniques.

"From there, I would exaggerate things and tell the guests that they could control their horse easy standing up in the saddle or riding backwards," he said. "My role soon turned more and more into an entertainer and less of an educator."

## Most traffic counts up on highways in county

Apart from a decline in commercial traffic on Kansas Highway 16 west of Holton, overall traffic on Jackson County's highways was on the increase in 2016, according to the Kansas Department of Transportation.

KDOT's Bureau of Transportation Planning, in cooperation with the U.S. Department of Transportation's Federal Highway Administration, recently released its annual Kansas Traffic Flow Map for 2017, which estimates the annual average daily traffic on the state's main roads, whether state, federal or interstate routes, for the year ending Dec. 31, 2016.

Decreases of anywhere from 40 to 100 commercial vehicles per day were noted on K-16 from Holton west to the Pot-

tawatomie County line, with the declines more pronounced closer to Holton. However, commercial traffic on Kansas Highway 79, which connects K-16 with Circleville, saw an estimated increase of 25 commercial vehicles per day.

Overall traffic on K-16 west of Holton showed increases of 40 to 90 vehicles per day, again with the more sizable increases closer to Holton. Overall traffic counts on K-79 and Kansas Highway 62, which connects K-16 with Soldier and Nemaha County, were up modestly where increases were noted.

East of Holton, the combination of K-16 and Kansas Highway 116 showed a 45-vehicle decline in commercial traffic, but a 60-vehicle increase in overall

## County purchases three graders

Three new motor graders have been purchased for Jackson County's road and bridge department, it has been reported.

During Monday's Jackson County Commission meeting, the commissioners approved the purchase of three new John Deere motor graders at a total cost of \$658,000 from Murphy Tractor of Topeka.

The county also agreed to sell three of its older motor graders to Foley Equipment of Topeka for a total cash value of \$149,000. Those funds will be used towards the purchase of the new machines, it was reported.

The county agreed to purchase an all-wheel drive John Deere motor grader from Murphy for

## After school program to continue at Holton

The "after school" enrichment program for elementary students in grades K-5 will continue this year in Holton USD 336 Mondays through Thursdays, it has been determined.

At its meeting here Monday evening, the school board approved the program with a \$2 per day fee per child.

For the last 4 1/2 years, the Holton school district received a federal grant to cover the cost for the after school program.

Last year, it was learned that the federal funds for the program would not be renewed. Since then, school officials have been researching how to continue it.

At Monday evening's board meeting, it was learned that Elementary Principal Beth Smith had developed a plan to fund the program with a \$26,000 budget — about half of what the federal grant had provided in funding.

Superintendent Bob Davies, in support of the after school

program, said the district could utilize some "at risk" funds provided by the state to cover about half of the costs for the program, also.

More information about the after school program will be shared with parents at enrollment, Davies said, with sign-up for the program scheduled for 3 p.m. to 7 p.m. on Aug. 9 at the elementary school.

The program is set up for about 50 kids, Davies said. The program operates from 3:05 p.m. to 5:30 p.m. each day. Kids are provided a snack and also given time to complete any homework they may have, plus they are provided with other educational enrichment activities.

Davies said he would like to see as many kids as possible take advantage of the after school program. The \$2 per day, he said, will be the maximum fee per child. Parents should visit with school officials about the daily fee.

## KHA laments \$2 billion lost by non-expansion of KanCare

As of Wednesday, July 19, the total amount of federal funds Kansas has forfeited by not expanding KanCare has reached \$2 billion, according to the Kansas Hospital Association.  
 KHA officials said that amount represents an average loss in Kansas taxpayer dollars of \$18.40 every second since Jan. 1, 2014. These funds have gone to the federal government to be spent in other states for Medicaid expansion.  
 The Kansas Hospital Association maintains a live ticker demonstrating this growing loss

in funding at www.kha-net.org. With the recent failure of the Better Care Reconciliation Act, Kansas still has the opportunity to expand coverage to approximately 150,000 hardworking Kansans who fall in the health care coverage gap.  
 The Kansas Legislature nearly accomplished expanding Kansas' program in its last session, and health care advocates will continue to work on a Kansas solution to expand KanCare, KHA officials said.  
 Independent sources estimate expanding KanCare would actu-

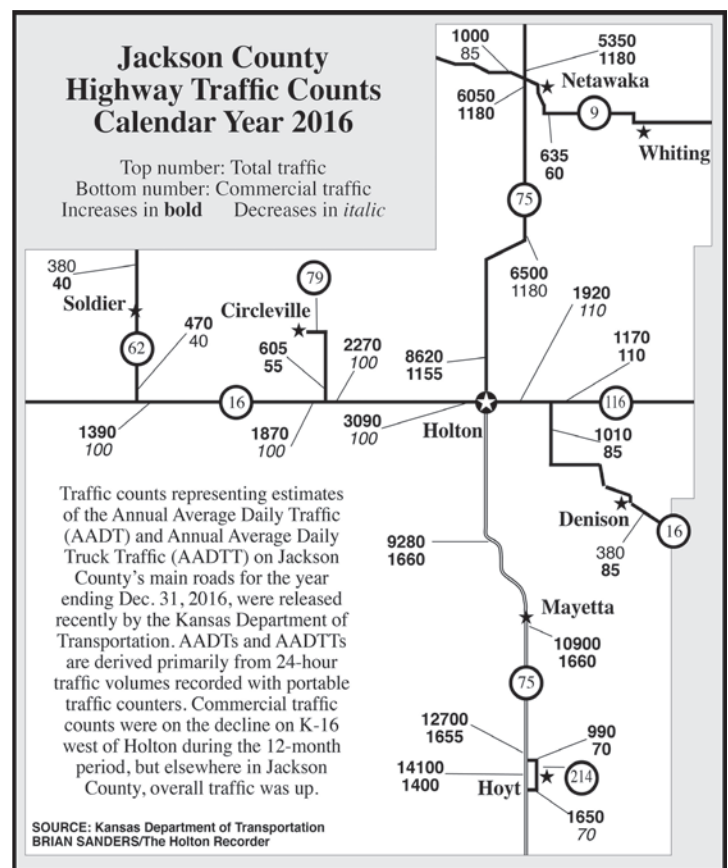
ally bring hundreds of millions of dollars in net financial gains annually through at least 2025 – a stark but welcome contrast to the loss of \$2 billion that Kansas has seen due to inaction on expanding KanCare.  
 KHA officials said Kansas hospitals will continue to work with elected officials to address concerns with federal health care reform in hopes that Kansas will have the opportunity to keep money within the state to improve access to health care coverage for Kansas citizens.

## Analyst: More gas price hikes possible

Gasoline prices are on the rise in northeastern Kansas, and the outcome of this week's meeting of the Organization of Petroleum Exporting Countries (OPEC) could cause prices to go higher, according to Patrick DeHaan, senior petroleum analyst for fuel price monitoring Web site Gas-Buddy.com.  
 "Over the last week, gasoline prices have risen across a majority of the country, following the price of oil, which has been

rising as of late," DeHaan said. "OPEC's meeting this week could steal the focus and propel markets higher or lower, depending on the outcome of the meeting, but for now, the most likely outcome would put pressure on oil prices to rise, especially if there's talk of another oil production cut from the cartel."  
 Average retail unleaded gasoline prices in Kansas have risen 1.9 cents per gallon in the past week, averaging \$2.09 per gal-

lon on Sunday, according to Gas-Buddy's daily survey of 1,329 gas outlets in Kansas. The national average has increased 2.1 cents per gallon in the last week to \$2.27 per gallon, while in the Holton area, the average price has remained steady at \$2.08.  
 Including the change in gas prices in Kansas during the past week, prices on Sunday were 7.6 cents per gallon higher than the same day a year ago and are 4.1 cents per gallon higher than a month ago. The national average has increased 1.4 cents per gallon during the last month and stands 11.7 cents per gallon higher than the same day a year ago.

## Greatest risk to natural gas pipeline is accidental damage

Did you know that, before you dig, it is required by law to call 811 to have all buried utility lines located and marked?

Atmos Energy wants to thank homeowners and excavators alike for observing the law and keeping our communities safe by always calling 811 before digging.

Since 2008, Atmos Energy has seen a 47 percent increase in requests by the public to have underground natural gas lines marked. Once underground utility lines are marked, it is important to take special care around all line markings by digging by hand.

Every time the excavating public calls 811 before digging, the chance of them hitting an underground utility line then decreases by 99.9 percent.

which notifies the appropriate utility companies of their intent to dig. Professional locators are then sent to the digging site to mark the locations of underground utility-owned lines with flags and spray paint, free of charge.

"Atmos Energy located 2.1 million underground natural gas lines in 2016. We appreciate our customers observing this important safety law. Calling 811 is the law in every state that we serve. All excavators call 811 at least three business days before digging on public or private property," said Paris.

## PLAINS FOLK: Lobstering has stories of conflicts, too

When I was growing up, the dogs and I spent a lot of time down at the creek.

The "crick" (to use the vernacular of the Flint Hills) that ran through our place was actually the upper reaches of the Walnut River, although the only time that it flowed was during the rainy season.



There were several holes that would hold water for a while after the crick had stopped flowing, however, and there I would take a homemade seine (a split-open gunny sack with each side attached to strips of lath) and catch minnows and crawdads.

In Louisiana, crawdads (also called crayfish or crayfish), are part of the celebrated cuisine: as Hank Williams sings: "jambalaya, crawfish pie, and file

gumbo."

I've eaten crawdad occasionally, but I much prefer its larger cousin, the lobster.

I was in my mid-20s when I ate my first one. That was in a St. Louis restaurant, and I'm sure my puzzlement at getting through the shell to the sweet lobster meat inside was a source of amusement for the waiter and the other diners.

Recently, Cathy and I made our first trip to Maine, whose coastal waters provide 90 percent of the lobsters eaten in the United States and 30 percent of those sold on the world market.

It's an annual \$1.5 billion industry in Maine, and it is the only certified sustainable lobster harvest in the world.

Our purpose for the trip wasn't just to eat lobster, but I did take advantage of the opportunity.

The most memorable lobster meal was at the home of a friend who lives on Peaks Island, a short ferry ride from Portland.

Elaine's house sits on the west side of the island, and her neighbor to the south is a lobsterman, his dock piled high with lobster traps.

At noon, we walked out on his jetty, where he had put some of the morning's catch into a bucket for us.

From the sea directly to the pot of boiling water on the stove - you can't eat lobster any fresher or any tastier.

A couple of days later, we took a boat excursion to an island to see puffins, seals and eagles. The young man providing commentary was a font of information about lobstering.

The small buoys that we had thought were marking the channels between islands, I learned, were actually marking lobster traps, of which there are some four million used by the 6,500 licensed lobstermen who operate in the seven lobster zones along the Maine coast.

During the height of the season, the traps are checked every couple of days, every week during slow times. Lobstermen have a small metal measuring caliper (or whatever it is called) with which to measure the distance between the lobster's eye and the point at which the tail attaches to the body.

The distance has to be at least

three inches and no more than five. Lobsters less than three are thrown back to grow bigger, over five and they are returned to the ocean as breeders.

The top part of the colorfully painted wooden buoys are conical with a round spindle extending below.

Each lobsterman has his own painted design, just as a rancher in cattle country has his own brand. In fact, in the museum at the Marshall Point lighthouse I even saw a branding iron used to mark the buoys.

Like cattle rustling in the Old West, lobstering has its own stories of conflict and vigilantism that arise when "rustlers" rob traps marked by someone else's buoys.

In one instance many years ago, our commentator on the boat said, the victimized lobsterman took revenge by killing the thief with a shotgun blast.

The jury, comprised of other lobstermen, meted out Maine justice: Not Guilty.

## AG WEEK: Steers, heifers sell \$3 to \$6 higher

Good support in the cattle market ended the week with corn pulling back down to support levels ahead of the week-end.

Cash feedlot trade was minimal heading into Friday with some light trade at \$118 live and \$188 dressed. By midday Friday, packers were paying up to \$120 live in Kansas and Texas.

USDA Ag Secretary Perdue authorized the use of additional Conservation Reserve Program (CRP) lands for emergency grazing and haying in and around portions of Montana, North Dakota and South Dakota affected by severe drought.

USDA is adding the ability for farmers and ranchers in these areas to hay and graze CRP wetland and buffer practices.

For the week, Friday, July 14, to Friday, July 21, August live cattle were down \$1.37, October was down \$1.17, August feeder cattle were down \$1.32, September was down \$.92, August lean hogs were up \$1.20 and October was up \$.05. Boxed Beef, Choice was down \$2.44 at \$206.91, Select was down \$.62 at \$194.80 and Pork Carcass Cutout was down \$1.70 at \$104.48.

Compared to last week, steers and heifers sold \$3 to \$6 higher with some instances \$8 to \$10 higher. There were several days of up and down, triple-digit moves this week at the CME;

big, volatile moves in the fu-

tures markets have become commonplace again, and while that often takes confidence out of the market, order buyers were able to shake off the uncertainty and still pay up some high prices, especially for yearling type cattle.

Cattle and calves on feed for the slaughter market in the United States for feedlots with capacity of 1,000 or more head totaled 10.8 million head on July 1, 104 percent vs. July 1, 2016, and above the range of pre-report estimates. Marketings of fed cattle during June totaled 1.99 million head, or 104 percent vs. June 2016.

The most impactful number was placements in feedlots during June, totaling 1.77 million head, 116 percent vs. June 2016 and 10 percent above the average trade estimate.

Placements by weight class show more lightweights coming into feedlots, below 800 lbs. near 125 percent of year ago while 800 lbs. or more were near 100 percent a year ago. This sent the market limit lower to begin this week.

The cattle inventory report is a little more difficult to assess since USDA did not release a report in July 2016. Some of the comparisons are versus two years ago. Overall, the continued expansion in numbers continues.

All cattle and calves in the United States, as of July 1, totaled 103 million head. This is

4 percent above the 98.2 million head on July 1, 2015. The 2017 calf crop in the United States is expected to be 36.3 million head, up 3 percent from last year's calf crop and up 6 percent from 2015.

The cold storage report released on Monday, though, was friendly with total red meat supplies in freezers down 3 percent from the previous month and down 7 percent from last year. Total pounds of beef in freezers were up 1 percent from the previous month but down 10 percent from last year. Frozen pork supplies were down 5 percent from last month and down 4 percent from last year.

Cattle slaughter from Friday was estimated at 115,000 head, matching the previous Friday and up 3,000 compared to a year ago. For the week, the total was 622,000 head, down 7,000 from the week previous but up 25,000 compared to a year ago.

Hog slaughter from Friday was estimated at 426,000 head, up 19,000 from a week ago and up 23,000 compared to a year ago. For the week, the total was 2,213,000 head, up 18,000 from the week previous and up 72,000 compared to a year ago.

August live cattle had support around \$114, and then the July low of \$112.42 with resistance up at \$118.65. August feeders' next level of support is \$148, then the \$144 area and next the June low at \$140.77. Resistance is just above \$155, tested a few times over the past couple weeks.

August lean hogs have been consolidating in price recently trading a \$3 range from roughly \$80 to \$83 with strong support just below \$78 which was tested four times back in June.

Back-and-forth weather trading in the grains wrapped up last week. Corn and beans still finished higher, week-over-week, along with Minneapolis wheat, but KC and Chicago wheat were lower and hitting some oversold conditions.

Some scattered rains did move through the Midwest, but it was light and scattered after many areas had seen a few days of 100-plus degree highs and near 80 degrees for overnight lows, not allowing plants to rest.

### Land owners need deer permits, too

Resident hunters and hunters purchasing deer permits available over the counter can obtain their 2017 permits beginning Aug. 1, it has been reported.

Deer permits available over the counter for the 2017 season include:

**Resident Any-Season White-tailed Deer permits** – Valid for one white-tailed deer buck, doe or fawn – may be used statewide in any season, using equipment legal for that season.

\$42.50 General Residents  
 \$22.50 Resident Landowner/Resident Tenant  
 \$87.50 Nonresident Tenant  
 \$12.50 Resident Youth (15 and Younger)

**Resident Archery Either-species/Either-sex Deer permits** – valid for one white-tailed or mule deer buck, doe or fawn – may be used statewide with archery equipment only during archery season.

\$42.50 General Residents  
 \$22.50 Resident Landowner/Resident Tenant  
 \$87.50 Nonresident Tenant  
 \$12.50 Resident Youth (15 and Younger)

**Resident Muzzleloader Ei-**

**ther-species/Either-sex Deer permits** – valid for one white-tailed or mule deer buck, doe or fawn – may be used either in the East Zone (3, 4, 5, 7, 16) or the West Zone (1, 2, 17, 18) during the early muzzleloader season and the regular firearm season. Hunters may use muzzleloading equipment only with this permit.

 \$22.50 Resident Landowner/Resident Tenant  
 \$87.50 Nonresident Tenant  
 \$12.50 Resident Youth (15 and Younger)

**Hunt-Own-Land Deer Permits** – valid any white-tailed or mule deer only on land owned or operated by the landowner or tenant during muzzleloader, archery and firearm seasons using equipment legal for that season – are \$22.50.

These permits may only be obtained by individuals who qualify as resident landowners or tenants, including family members living with the landowner or tenant.

**Resident Antlerless White-tailed Deer permits** – valid for any white-tailed deer without a

visible antler protruding from the skull – are available to any hunter who has first purchased a resident deer permit that allows the taking of an antlered deer, unless the antlerless permit is purchased on or after Dec. 30.

\$22.50 General Residents  
 \$10 Resident Youth (15 and younger)

Hunters may obtain up to five Antlerless White-tailed Deer permits; the first is valid in Deer Management Units 1 through 17 and 19, including lands managed by the Department. Additional Antlerless White-tailed Deer permits are valid in units 1, 2, 3, 4, 5, 7, 10A, 11, 12, 13, 14, 15 and 19, on private land with landowner permission, Walk-In Hunting Areas and Glen Elder, Kanopolis, Lovewell, Norton, Webster and Wilson Wildlife Areas and Kirwin National Wildlife Refuge.

No Antlerless White-tailed Deer permits are valid in Unit 18, and Either-Species Antlerless-Only permits are not available for 2017.

In time, the ranch began putting on Wild West Shows where Bausch would do trick roping and gun spinning.

"We ran a rodeo every week - 22 rodeos a season," he said of his 10 years at the ranch. "I was getting a hands-on education of the farrier sciences, horse training, barn management and the hotel and restaurant world."

After perfecting his rodeo skills at the dude ranch, Bausch began entertaining at corporate events, festivals and resorts.

"I've entertained 6,000 guests for Nike in Portland, Ore. and I performed at the 50th anniversary of Mustang in Detroit for Ford Motor Company," he said. "I've had some really exciting opportunities outside the United States as well."

While participating in a mounted shooting event in Wisconsin, Bausch met his wife, Paula, also an avid rider.

"Between the two of us, we have 22 world and national titles in mounted shooting," he said.

The couple has two children, Abram, 8; and Hannah, 6.

In 2011, Bausch was asked

to audition for "America's Got Talent" television show. He was the first mounted performer to ever appear on the show.

"The producers had seen my trick riding videos on YouTube," he said. "They scouts are always looking for diverse talent for the show."

Bausch put together a customized 90-second performance for the show's judges and live audience.

Although he wasn't selected to move forward in the competition, he said it was a positive experience.

During this weekend's Jackson County Fair Rodeo, Bausch said that members of the audience can expect a wide array of tricks.

"We're going to pull out everything," he said. "We'll give them the 'wow' of the Silver Screen cowboy era. They'll be tricking riding, gun spinning and trick roping. Rustler, the Black stallion trick horse, will be there playing dead, sitting and rearing."

Bausch and his family make their home in rural Arizona.

"We try to make it back to

Kansas each summer," he said. "I'm excited for my kids to experience a county fair. They don't hold them where we live."

The seventh annual rodeo will be held Friday and Saturday at the Northeast Kansas Heritage Complex just one mile south of Holton on U.S. Highway 75.

The rodeo will start with a boot scramble for the children ages three to 12. The boot scramble will have two age groups with cash prizes awarded to the top two finishers in each group, it was reported.

The rodeo will also include traditional events, such as riding, roping, broncs and bulls, along with mutton busting and mini bullriding for children.

Entrance is \$8 per person 12 years and older and \$6 per child 5 to 11 years. Children four years and under will be admitted for free. Coolers are permitted for a \$5 fee at the gate.

Gates will open at 6 p.m. with entertainment starting at 7:30 p.m. each evening. The facility is located at 12200 214th Rd. south of Holton, half a mile west of U.S. highway 75 on 214th Road.

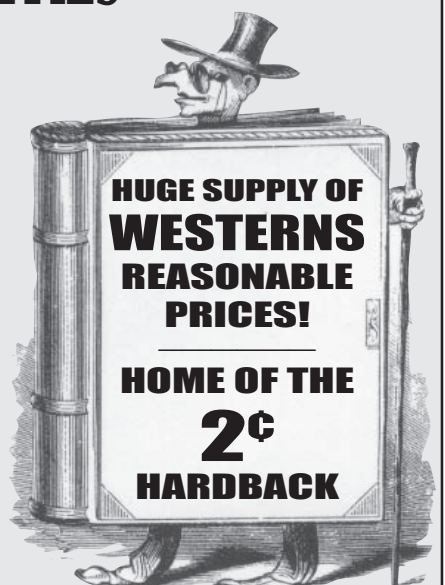

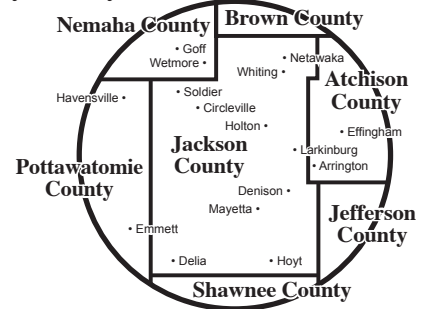

our plan. They'll provide the meat counter and operate it as a joint venture with us."

Cecil K's, however, will be a full grocery, providing more than just Heartland Meat Market's variety of meat products. Whorton said she and Bontrager have tapped Kansas City-based Associated Wholesale Grocers (AWG) to be the new store's chief grocery supplier, but they also plan to offer locally-grown produce through the store.

"We want to bring in as much seasonal produce as we possibly can to give local farmers a place to go with their produce," she said. "I think it would really be a win-win for local farmers to have a place where they can just come and drop off their products. We would buy from them at a bulk price and then sell it out of our store."

Cecil K's will offer "a leading edge grocery experience, comfortably located in a small store with easy access" to meat, produce and bakery items, Whorton said. The store will

also offer the latest in shopping technology, such as online ordering and grocery delivery options.

One thing Whorton and Bontrager are not ready to do yet, however, is say when the store is going to open. There's still a lot of preparation to go through before they can open the doors of Cecil K's Hometown Market to the general public.

"We just took possession of the building a few days ago," she said. "But we're really hopeful that we'll be open by the end of the year. We just want to get a little bit closer to being ready before we announced a firm opening date."

Whorton said she and Bontrager will be happy to offer Holton-area residents another option for grocery shopping.

"My grandma would tell you that she'd rather park right in front of the door, run in real quick for a couple of items that she needs and then be able to come right back out with super-easy access," she said.

traffic. As the two highways diverged, K-16 going toward Denison saw a 45-vehicle commercial traffic increase and a modest overall traffic increase, while K-116 heading into Atchison County showed increases of at least 30 vehicles per day in commercial and overall traffic.

The main traffic generator in Jackson County remains U.S. Highway 75, which saw increases in both commercial and overall traffic up and down the corridor. Some parts of the highway saw increases of more than 300 commercial vehicles per day, with the highway between Mayetta and Holton noting a daily increase of about 400 commercial vehicles.

North of Holton, however, U.S. 75 saw a more pronounced differ-

ence in traffic increases, with commercial truck traffic increases remaining in double digits — 35 to 80 commercial vehicles per day, with larger increases noted on the approach to Brown County — while overall traffic was up by anywhere from 160 to 260 vehicles per day.

Traffic counts as shown on the state map represent estimates of the annual average daily traffic (AADT) and annual average daily truck traffic (AADTT) for the year. These numbers are derived mainly from 24-hour volumes recorded by portable traffic counters that generate counts based on the number of vehicles that pass over sensors placed along roads.

These short period counts are adjusted for days of the week and seasonal variations based on data from 80 continuous automatic traffic recorders. Axle correction factors have been applied to each short period count, and minimal amounts of "smoothing" were applied where large, unexplained changes in traffic volumes were observed.

The 2017 Traffic Flow Map and other traffic flow maps from previous years are available for download in Adobe Acrobat (.pdf) format at the KDOT Web site (www.kdot.org) under the "Travel Information — State Maps" heading. Paper copies of the map may also be ordered from KDOT.

The total cost of the new digital sign will be closer to \$27,000 now, it was reported, after a couple of upgrade features were approved, such as having the top part of the sign cabinet light up and the display of time and temperature.

A portable version of the digital sign will be displayed throughout the community over the next week or so and in the upcoming fair parade, it was reported.

Wittmer and Aeschliman said the new sign will come with a five-year warranty and will cost between just 13 cents and 22 cents per day in electric costs to operate.

After the sign is built and becomes the property of the school district, it will also have very little impact on the district's overall annual insurance costs, it was reported.

The sign's value, as well, as it becomes school property, will also have very little impact on on-going local taxes, it was reported. Owners of a \$100,000 home, for example, may see a little 2 cent to 4 cent difference per year.

Lots of volunteer work will be utilized to activate the new sign, Wittmer and Aeschliman said. Eisenbarth Construction will soon pour a concrete pad for the sign. Salts Masonry will use left-over bricks from the new elementary school for the new sign's base. McManigal Electric will provide the necessary wiring expertise.

Board members asked Wittmer and Aeschliman to consider setting up a maintenance fund for the new sign with any funds raised beyond what will take to pay for the sign.

Donations for the new sign are being accepted at the district office, it has been reported. Checks should be made out to the Holton Education Foundation with new sign indicated in the memo line.

Classes have not started yet but the school board is already talking about graduation.

Wittmer said he would like the board to decide whether non-academic cords will be allowed at Holton's high school graduation ceremonies.

Academic cords — worn by graduates over their graduation gowns — are allowed at Holton's high school graduation ceremonies to signify academic achievement and National Honor Society membership at the school, Wittmer said.

Wittmer said that at last year's graduation, some graduating seniors wanted to wear cords with the phrase "Seat Belts Are For Everyone" on them. That request was denied, he said, as was one to have a graduating senior wear a cord indicating they had signed up for the military.

Wittmer said he was not in favor of allowing cords or stoles (sashes) for non-academic achievement purposes but was not opposed to allowing pins approved by the school to be worn on the lapel of the graduation gowns.

School board members said they would survey other high schools to see what is allowed these days and a decision would be made later.

In other business, the school board:

\*Noted the absence of board president Rex Frazier and board member Bob Phillips.

\*Approved bills totaling \$959,617.97.

\*Accepted the following donations for the new digital sign at the high school campus — Medical Pharmacy, \$1,000; Holton Youth Football, \$1,000; Mercer Funeral Home, \$1,000; Kellerman Real Estate, \$500; Kellerman Insurance, \$500; Rhino Fitness 5K Run, \$555; Holton Dental, \$500; Lifetime Eye Care, \$1,000; Schlaegel-Yingst Accounting, \$100; Roger and Lucy Burdiek, \$100; and Tanking LLC, \$100.

\*Accepted the resignation of Ellen Gorden, pre-school paraprofessional.

\*Accepted the milk bid from J&R — 1 percent = 20.92 cents per carton, skim chocolate = 21.88 cents per carton and skim strawberry = 21.99 cents per carton.

\*Tabled discussion of policy updates suggested by the Kansas Association of School Boards.

\*Learned that a proposed new budget for the school district will not be available for review until sometime early next month.

\*Approved a new job title. Innovation specialist was the new job title given to Annie Brock, it was reported. Initially, Brock was hired as communication resource specialist.

\*Approved \$500 mentor stipends for the following teachers — Amy Oldehoeft, Andrea King and Abbey Althof. These three teachers will work with three new teachers to provide support for them over the school term.

\*Discussed having a surplus equipment auction in October at the Fresh Start building.

\*Approved a motion at 7:15 p.m. to enter into executive session to discuss non-elected personnel — an employee's performance — for 10 minutes with Supt. Davies.

\*Upon returning to open session, approved a motion at 7:27 p.m. to enter into executive session for 15 minutes to discuss the privacy interest of a business with Supt. Davies.

\*Returned to open session at 7:42 p.m. and approved a motion to hire Lane Lassiter as a middle school assistant coach.

\*Discussed a sports medicine agreement. Board members said they had some questions about services to be provided to the schools under the annual contract. Wittmer said he would get some more details about the contract for the board's August meeting.

\*Adjourned the meeting at 7:51 p.m.

\$240,000 in addition to two rear-wheel drive John Deere graders at a cost of \$209,000 each.

Two other bids were received for motor graders from Berry Tractor of Topeka and Foley Equipment.

Foley Equipment bid \$278,433 for an all-wheel drive machine and \$246,638 each for two rear-wheel drive motor graders for a total cost of \$771,709.

Berry Tractor did not submit a bid for an all-wheel machine, but included a bid for two rear-wheel machines at \$235,764 each for a total cost of \$471,528 for two graders.

The commissioners and Dan Barnett, road and bridge director, agreed to sell three of the county's older motor graders instead of trading them in.

The best purchase bid was from Foley for \$149,000 total for the three machines: a 2009 Caterpillar 120M (\$55,000), a 2009 Caterpillar 12-H (\$51,500) and a 2008 Komatsu (\$32,000).

Each of the machines has more than 10,000 hours on it, it was reported.

Murphy Tractor bid \$104,000 to purchase the three machines from the county.

Berry Tractor did not submit a purchase bid.

The county now owns a total of 11 motor graders. None were purchased last year. Two machines were purchased two years ago.

Commission Chairman Rob Ladner said that the road and bridge department is working on creating a rotation schedule for motor grader purchases so the purchases can be spread out over time.
